



MEDICAL MALPRACTICE

Medical malpractice is when a patient is injured due to an act or omission by a physician or health care professional who deviates from accepted standards of practice in the medical community. Medical malpractice cases are in general, extremely complex and usually involve very serious injuries or fatality. In some cases, there may not be an immediate or obvious cause and effect. Thanks to the Internet, information about medical malpractice has become more readily available to the general public. Unfortunately, there is no guarantee that such information is accurate and unbiased, and therefore, much of it can be unreliable. The only credible way to know whether you or a loved one has



been a victim of malpractice is to consult a highly qualified lawyer. The lawyers at Wolske & Associates will obtain copies of all of your hospital and physician records. A claim will only be filed if a strong case for medical negligence has been validated by expert medical opinions. Ohio law mandates that medical malpractice claims must be filed within one year of the time an error was discovered, or should have been discovered, or one year from the termination of the doctor patient relationship, whichever occurs later. The life altering effects of a medical mistake can be devastating, especially when the outcome requires long term care for disabilities. MOTOR VEHICLE ACCIDENTS

BIRTH INJURIES

A birth injury is legally defined as any serious injury that a child suffers just before, during, or shortly after birth. It is estimated that 30,000 birth injuries occur each year in the United States. Many of these injuries are the result of medical malpractice. In these situations, parents are often unaware that their child's injuries could have been prevented. If you suspect that your child has been the victim of a birth injury at a hospital, the attorneys at Wolske & Associates can help. NURSING HOME NEGLIGENCE

The most common injuries to nursing home residents include pressure sores, malnutrition and dehydration, falls, elopement and medication errors. CASES FROM THE LAW FIRM'S FILES



Hamilton County, Ohio: Diagnosis of an aggressive liposarcoma cancer tumor behind the knee was missed in a 48-year-old male. The cancer metastasises and the man died a wrongful death.

Franklin County, Ohio: Defendant repairing roof top air conditioner, threw a box of parts off the roof and hit Plaintiff in the head, causing traumatic brain injury. Franklin County, Ohio: Brain injury suffered at birth due to the negligence of a resident and nurses in evaluating and failing to appreciate the emergent nature of the distress. Failure to call a doctor for a timely Cesarean section.

Logan County, Ohio: An obstetrician's failure to heed standard guidelines for timely diagnosis of intrauterine growth retardation, directly resulted in brain injury to the infant.

Allen County, Ohio: The Plaintiff was operating a motorcycle when Defendant turned her vehicle in front of him, thus causing a collision. Injuries included a concussion, fractured teeth, leg fracture, and left brachial plexus injury.

Washington County, Ohio: A forty-one year old, whose hand was caught in an elevator some six hours before, was presented to an emergency room and released. The physicians failed to diagnose compartment syndrome and ultimately, the patient lost his hand.

Morrow County, Ohio: An elderly lady suffered neurologic injury from an undiagnosed abscess after neurosurgery, resulting in partial paralysis and other problems.
